Disclosure and Agreement Section

This agreement is a contract. Please read it carefully.

This agreement governs the use of a User Identification Number and Password (LOGIN) with a capacity to access the Waukesha State Bank Internet information system, and is issued to you, upon your request. You agree to be bound by all terms and conditions of this agreement the first time you use your Waukesha State Bank LOGIN to access your retirement plan accounts. You also agree through the use of your LOGIN to be bound by any change in these terms which may be published via Waukesha State Bank's services while you are a user of these services. If you do not want to be bound by the terms of this service agreement or by any subsequent changes to these terms, please contact Waukesha State Bank immediately so that we may cancel your Internet access.

- **On-line Services.** In offering these Internet services, Waukesha State Bank is making available to you interactive computer services that allow you to access account information for each account we maintain for you. Waukesha State Bank may terminate this on-line service or your access to it at any time.
- **Limitation of Liability.** Waukesha State Bank will take reasonable security precautions in storing and transmitting private data communications, but you agree that Waukesha State Bank will not be liable for any claim, loss, cost, or expense resulting from interception of or other unauthorized access to any such data or communications. Waukesha State Bank cannot guarantee that the system and your accounts are 100% secure from access by unauthorized users. You agree that Waukesha State Bank will not be liable to you for any direct, indirect, consequential, special, or punitive damages or losses whatsoever that you may incur in connection with the use of Waukesha State Bank's system or with any of the data or other materials transmitted through or residing on Waukesha State Bank's system, even if Waukesha State Bank has been advised of the possibility of such damage or loss. This includes, but is not limited to, the loss of data or any other loss resulting from delays, non-deliveries, or service interruptions of any nature whatsoever.
- **No Warranties.** Waukesha State Bank makes no warranties of any kind, whether expressed or implied, as to the availability, accuracy, or content of the information, products, or services it is providing, and disclaims any warranty of merchantability or fitness for a particular purpose. Use of any information or data obtained via Waukesha State Bank is at your own risk. Waukesha State Bank bears no responsibility for the accuracy or quality of information obtained through its services. Waukesha State Bank is not responsible for any charges incurred through access to Waukesha State Bank. In no event, will Waukesha State Bank be liable for any damages or losses of any kind resulting directly or indirectly from any use of or defect in these Internet services or any other Waukesha State Bank electronic service, unless expressly stated in this agreement.

- **Partial Invalidity.** If any provision of this agreement is ruled invalid or unenforceable, you agree that the remaining provisions will continue in full force and effect. This is the sole legal agreement governing the use of these Internet services. This agreement will be governed by and interpreted under the laws of the State of Wisconsin, as if this agreement were entered into and performed completely in Wisconsin. You agree that all lawsuits relating to this agreement or these Internet services shall be brought in Wisconsin state courts located in the City of Waukesha, Wisconsin.
- **Application Section; Changes.** The application section of this form, which you are required to complete and sign, is hereby incorporated into this agreement. You agree that Waukesha State Bank may modify any terms and conditions of this agreement by notifying you via Waukesha State Bank's services in advance of the effective date of such a change.
